From Bradenton - Fort Myers - Sarasota

Go 1-75 North Get on the Crosstown Expressway (toll road). Get off at the Kennedy Exit. Take a right on North Florida Ave. Go four blocks. The courthouse will be on the right. OR Exit 60 West. SR 60 turns into Kennedy Blvd. Turn right on North Florida Ave. Go four blocks. The courthouse will be on the right.

From Brooksville - Dade City

Go 1-75 South Take 1-275 South. Take Exit 44 and go south on Ashley Dr. Go left on Cass St. for three blocks. The courthouse is on the right at the cross street of North Florida Ave.

From Clearwater - Largo - Palm Harbor

Take Highway 60 across Old Tampa Bay (Courtney-Campbell Causeway). Follow Highway 60 East towards Tampa. Get on 1-275 North. Take Exit 44 and go south on Ashley Dr. Go left on Cass St. for three blocks. The courthouse is on the right at the cross street of North Florida Ave.

From Lakeland - Plant City

Go 1-4 West Get on 1-275 South and get off at Exit 44. Go south on Ashley Dr. At Cass St. go left for three blocks. The courthouse is on the right at the cross street of North Florida Ave.

From Lutz - Temple Terrace

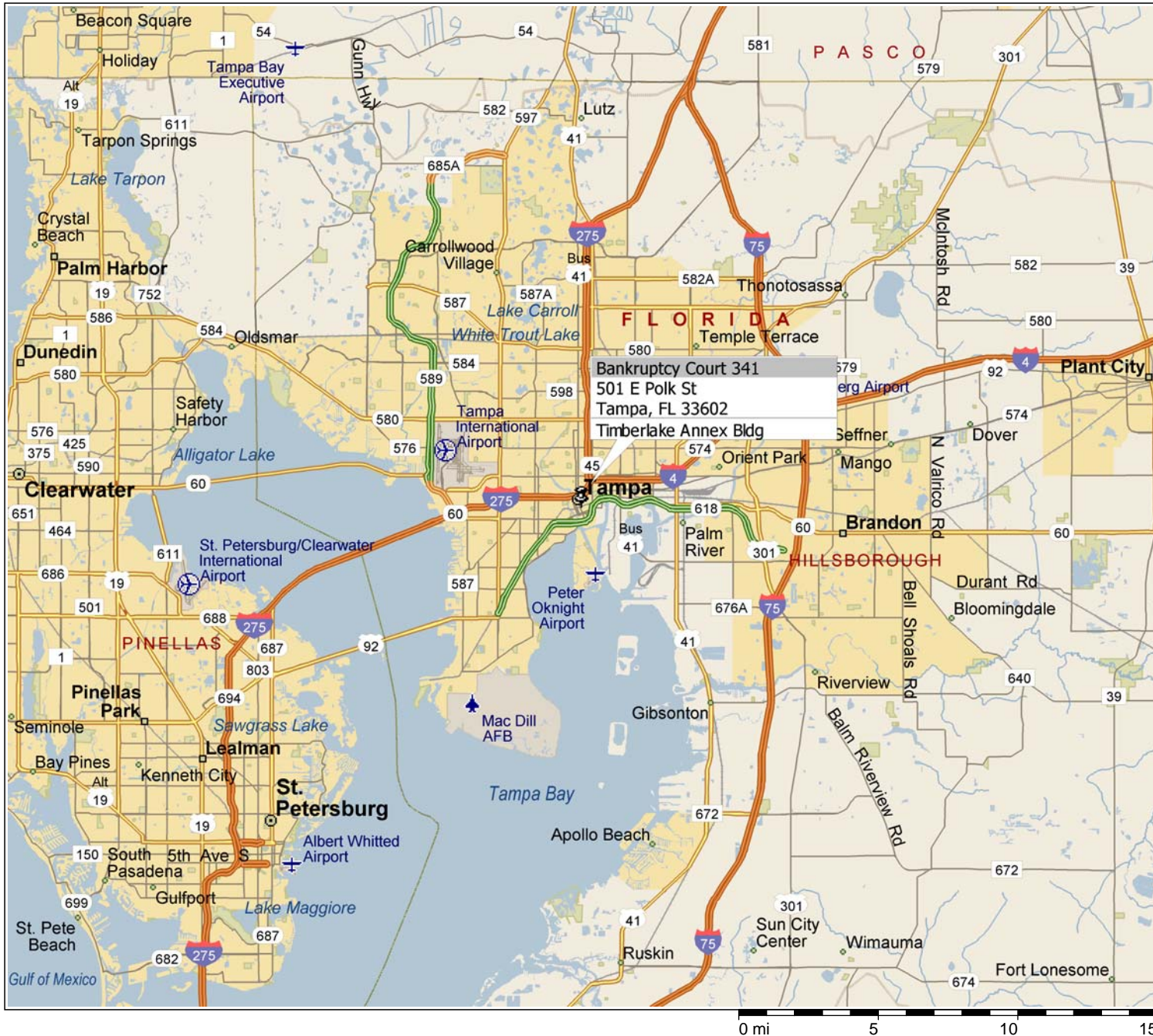
Go 1-275 South Take Exit 44 and go south on Ashley Dr. Go left on Cass St. for three blocks. The courthouse is on the right at the cross street of North Florida Ave.

From St. Petersburg

Go 1-275 North Take Exit 44 and go south on Ashley Dr. Go left on Cass St. for three blocks. The courthouse is on the right at the cross street of North Florida Ave.
